IRISH PAYROLL SERVICES

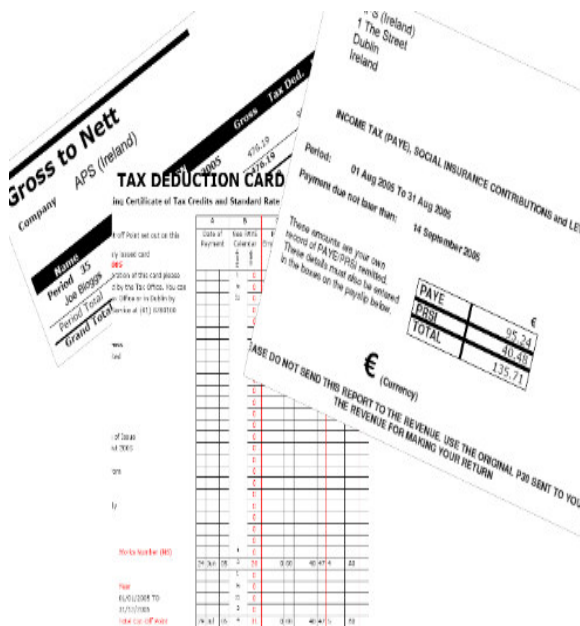


Many UK companies are expanding overseas, and the most obvious choice is the Republic of Ireland. They speak the same language, are part of the EU, and have similar business practices. However, their payroll is completely different to the UK. Although Tax is still called PAYE, the equivalent of NI is called PRSI. The tax year starts in January, not April, and Tax Credits mean something completely different!

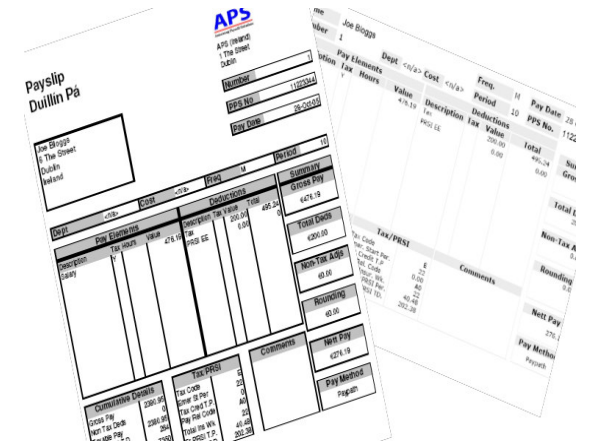
WHY OUTSOURCE?

Irish payrolls are completely different to their UK counterparts. Just because someone can process a UK payroll doesn't mean that they will be able to do the same with an Irish one. Statutory payments, such as Sickness benefit and Maternity benefit are treated completely differently. These benefits are paid direct to the employee by the Irish Revenue, and then the benefit can be given back to the employer to take into account with the wages. Everyone has a Tax Credit and Standard cut off point, which is the equivalent of the UK Tax Code. The Irish P30 is the UK P32. The differences are more than superficial. As in the UK, if you do not process the payroll correctly, there are large penalties. Our team all have at least 3 years of processing payrolls, so you will be in safe hands.

WHAT'S INCLUDED

After the initial set-up process, our Irish payroll solution comprises of the following: Providing a spreadsheet or database for you to enter the variable pay details (i.e. overtime, sickness absences etc), collection, collation and input of these hours, calculating all statutory payments, PAYE and PRSI and liaising with the Revenue. Providing a payment list or file for interfacing with your own bank/paypath software, or for faxing to your bank. A set of comprehensive reports sent to you via email in Adobe Acrobat pdf format (paper copies posted to you for a small cost). We can email you a file with payslips for free if you want to print and distribute them yourself, or we can print and post them to either your offices, or to each employee's home address.
